

We understand the FAFSA does not always capture the current financial snapshot of your household and that certain circumstances may present your family with unique financial challenges. By completing this form and following the steps below, we will be able to determine if these factors affect your financial aid eligibility. NOTE: Students are expected to borrow full federal loan eligibility prior to filing an appeal.

If after filing the FAFSA your expected family contribution is calculated at zero (0), you have already received your maximum financial aid package. Rather than filing an appeal, please contact the Financial Aid Office, or your admission representative if you are a prospective student, to discuss affordability options.

APPEAL INSTRUCTIONS:

1. Gather all the documentation required for your extenuating circumstance including the verification documents (Step 1) required of all students appealing. Your appeal will be delayed if you fail to fully complete this form or attach all required documentation.
2. Submit all required information and documents to the Financial Aid Office, Concordia College.

3. Appeals are reviewed within 30 days after receipt of required and supporting documentation. Incomplete appeals will be delayed – ensure you have included all items for a quicker response time.

ACCEPTABLE SPECIAL CIRCUMSTANCES CONCORDIA WILL CONSIDER:

- Loss or reduction of income or benefits due to death of parent; divorce or separation of parents; unemployment; disability, injury or illness of parent; natural disaster; foreclosure; loss of child support, etc. which occurred in 2018 or 2019
- Excessive medical or dental expenses not covered by insurance or reimbursed that exceed 7 percent of the family's adjusted gross income
- Private tuition expenses for a sibling enrolled at an elementary or secondary school in 2019-20
- Parents' personal college loan payments
- Parent attending college in 2019-20

APPEALS CONCORDIA WILL NOT CONSIDER:

- Consumer or credit card debt
- Early retirement (before age 65) unless health related
- Loss of windfall income such as lottery, gambling, bonus, or overtime income
- Mortgage or car payments
- Reduction in 401K or retirement values
- Weddings, vacations or other lifestyle costs
- Parents' refusal to support educational expenses

Step 1: Verification Process:

Concordia College policy requires **all** financial aid applicants filing an appeal to first confirm that the information provided on your FAFSA is accurate via the verification process. To complete this process supply the following:

- **Completed Household Information form** at www.concordiacollege.edu/files/resources/householdinfo1920.pdf
- **SIGNED copy of parents' 2017 federal tax return**
- **Copies of parents' 2017 W-2 forms from all employers.** If self-employed include Schedule C, C-EZ, or F of the federal tax return, or IRS Schedule K-1 (Form 1065).
