Day 1: Wednesday, May 20, 2026 • Departure

Our journey begins as we board our international flight bound for Vienna, Austria. **Inflight Meals**

Day 2: Thursday, May 21, 2026 • Vienna

Upon arrival at the Vienna airport we meet our guide and driver and transfer to our hotel. This afternoon a local guide joins us for a tour of the outer ring and major sights of Vienna before a welcome dinner this evening. **D**

Day 3: Friday, May 22, 2026 • Vienna

This morning, we explore the inner ring of Vienna today with a walking tour. We see Belvedere Palace, the elegant Kärtner Ring, St. Stephen's Cathedral, and more. Our walking tour includes inside visits to St. Stephen's Cathedral and the Imperial Treasury. This afternoon we visit Schönbrunn Palace, the summer home of the Hapsburg. We take a guided tour of the grand palace and have time to explore and enjoy the grounds. We also stop to sample a world-famous torte at the Sacher Hotel. Dinner this evening is at a local winery where we enjoy wine and typical Viennese dinners. **B/D**

Day 4: Saturday, May 23, 2026 • Vienna

Today we visit the Kunsthistorisches Museum, home to one of the world's finest collections of art and artifacts. Afterward, we take a leisurely stroll through the Naschmarkt, Vienna's most popular market, where we can sample local delicacies and experience the vibrant atmosphere. The rest of the day and evening we have free time to explore Vienna at our own pace. **B**

Day 5: Sunday, May 24, 2026 • Salzburg

This morning, we cruise along the most beautiful section of the





Danube from Vienna to Melk where we visit the magnificent Benedictine Abbey, resting majestically on its promontory above the Danube. Known as the "Cradle of Austria" more than a thousand years ago, Melk today is an historian's paradise with the Old Gingerbread House (1657), the Post Office (1792) and the 15th-century Gothic church. Our coach meets us in Melk and take us the rest of the way to Salzburg where the Sounds on Music and Mozart come to life. Dinner is at our hotel tonight. **B/D**

Day 6: Monday, May 25, 2026 • Salzburg:

Following breakfast, we board the motorcoach and drive to Salzburg. Upon arrival, a local guide takes us on a walking tour of Salzburg, including the impressive Cathedral, the catacombs, the Getreidegasse, the narrow, bustling pedestrian zone, Mirabell Gardens, Mozart's birthplace and the Mozarteum with the Zauberflötehäuschen (Magic Flute House). The afternoon is free to explore this wonderful old city. We enjoy dinner together in a local restaurant. **B/D**

Day 7: Tuesday, May 26, 2026 • Salzburg

Our morning begins with a ride on the funicular up to Hohensalzburg Fortress, one of Europe's largest and most impressive medieval castles. Here, we embark on a guided tour, exploring its rich history and architectural grandeur while taking in breathtaking panoramic views of Salzburg and the surrounding Alps. Following this, we head to the Stiegl Brewery, Austria's largest privately-owned brewery, for an insightful tour that reveals the intricate brewing process. We also get to enjoy some tastings of their finest brews. Our visit culminates with a late lunch at the brewery's on-site restaurant, where we savor traditional dishes perfectly paired with Stiegl's own beers. The remainder of the day is free to explore on our own. **B/L**





Day 8: Wednesday, May 27, 2026 • Klagenfurt

We journey to Hallein this morning where we done miner's garb and slide deep into the earth to learn about the important medieval industry of salt mining which made this area prosper. After resurfacing we board a local coach, we depart for Klagenfurt where we spend two nights at a spa hotel. This evening, we take a stroll along Lake Wörthersee. **B/D**

Day 9: Thursday, May 28, 2026 • Klagenfurt

This morning, we visit Minimundus, a fascinating miniature park, followed by a stroll through the beautiful Botanical Garden of the University of Klagenfurt. Next, we explore the charming Old Town of Klagenfurt with a local guide, who will share insights into the area's rich history and culture. This afternoon is free for you to enjoy at your leisure. Choose from various activities, such as unwinding in the spa facilities, taking a scenic boat trip on Lake Wörthersee, exploring the historic Maria Loretto Castle situated on a picturesque peninsula, or visiting the Robert Musil Literature Museum to delve into the works of the famous Austrian writer. Dinner is on our own tonight. **B**

Day 10: Friday, May 29, 2026 • Graz – Vienna

We make our way back to Vienna today, stopping to explore the vibrant city of Graz enroute. In Graz, a local guide will join us to showcase the city's iconic landmarks, including the magnificent Cathedral of St. Aegidius and the historic tomb of the Habsburg family. We marvel at the remnants of the old fortress wall and the legendary double spiral staircase from the 15th century. As we stroll through the charming city streets, we'll be serenaded by the melodic bell ringing and captivated by the dancing couple at the city's oldest outdoor attraction. On the main square, near the old Town Hall, our guide will regale us with the love story of the Habsburg family. Then we continue to Vienna where we gather for a farewell dinner. We share a glass of wine and toast to our Austrian adventures. **B/D**

Day 11: Saturday, May 30, 2026 • Return

We bid farewell to Austria with a heartfelt "So long, farewell, Auf Wiedersehen, goodbye" as our adventure comes to an end. We transfer to the Vienna Airport for our return flight home, cherishing the memories we've made along the way.

Currency exchange rates fluctuate constantly. In the event of a significant drop in the value of the dollar, we reserve the right to add a currency surcharge to the price of the tour.

Refund/Cancellation Policy:

All cancellations must be in writing. The date of postmark will determine the amount of refund due. Refunds are based on the number of days prior to departure date. From the time of deposit to 120 days before departure a \$100/person administrative fee plus any airfare & land penalties will be assessed. From 119-31 days, a \$300/person cancellation penalty plus lost airfare deposits and any unrecoverable deposits to ground suppliers will be assessed. Airline tickets once purchased are nonrefundable. Anyone canceling 30 days or less prior to departure will receive no refund.

Purchase of health, baggage, and trip cancellation/interruption insurance is strongly recommended.
